

MEMORANDUM OF AGREEMENT
Regarding the
Athletic Director (AD)/Athletic Coordinator (AC)

Between the Medina Teachers' Association and the Chief School Officer of the Medina Central School District.

WHEREAS, the Medina Teachers' Association (MTA) and the Board of Education of the Medina Central School District (District) are parties to a Collective Bargaining Agreement (Agreement) for the period of July 1, 2019 through June 30, 2024; and

WHEREAS, the MTA and the District have negotiated compensation for the position of Athletic Director (AD) in Article XVII, Part B based on certain responsibilities of that position; and

WHEREAS, the MTA and the District wish to both modify the responsibilities of the AD, and create a new position of Athletic Coordinator (AC); so

NOW, THEREFORE, IT IS AGREED THAT:

1. The AD portion of the responsibilities will be filled by an administrator and be compensated as per their contract. The AD will be responsible for the duties as listed below.

THAT, this agreement relates solely to the circumstances set forth herein and shall not be cited as precedent in any other administrative or judicial forum by either party.


